Our fixed cost for surrogacy is \$149,900

Costs Not Associated With American Surrogacy Fixed Fees

IVF Fees: All IVF clinics have their own standards and practices for medications, style of procedure and timelines. Due to this, our fixed fee does not include the IVF fees because they are variable by clinic and location.

Newborn Expenses: In the majority of cases, the intended parent's health insurance should cover newborn expenses.

Intended Parent Travel: If you desire to travel to the surrogate to be alongside her through medical appointments, your travel expenses would be the Intended Parent's responsibility.

Surrogate Out of Pocket Delivery Expenses: Any expenses not covered by the surrogate's insurance will be the responsibility of the intended parents.

Surrogate Breast Milk: If you would like your child to have breast milk and your surrogate consents to this process, an additional fee will incur to complete this process. This will occur on a weekly basis and the fee is approximately \$200 a week.

Varied Surrogate Experience and Location*: Based on the location and experience of the surrogate you choose, additional fees may occur to accommodate her needs.

Additional/Secondary Surrogate Mother Insurance*: Based on the insurance needs of the surrogate, additional fees may occur at time of match.

*You can turn down this surrogate journey at the time of match if this exceeds your surrogacy budget.

Our two installment fee payment structure

The first installment is **due at activation.** The second installment is **due at the time of match** with your surrogate. The following page includes the line-by-line cost breakdown of the American Surrogacy fee structure.
